The meeting was called to order at 9:21 a.m. by Ms. Cabrera.

Item 1 on the agenda was a Roll Call. Attendance, as listed above.

Item 2 on the agenda was the Pledge of Allegiance.

Item 3 on the agenda was the approval of minutes from the board meeting held 05/04/17. Ms. Brousseau moved that the minutes be approved as presented. Mr. Duffner seconded the motion and it carried unanimously.
