# Department Overview

## PIMA COUNTY SHERIFF'S DEPARTMENT

Managed from the Clarence W. Dupnik Sheriff's Complex at 1750 East Benson Highway, the Department serves the community with a community policing philosophy. Geographically, Pima County is the seventh largest county in the nation. The challenge to provide expeditious responses to calls for service has been met through seven strategically placed District Offices surrounding the metropolitan Tucson region. Additional satellite offices are located in Robles Junction, Mt. Lemmon, and Catalina.

The United States Department of Justice (DOJ), recommends the total average ratio of deputies per every thousand residents.<sup>1</sup> In Pima County for the population we serve, we should have 2.6 deputies per every thousand residents. Currently, we have 1.1 deputies per thousand, this is less than half the DOJ recommendation.

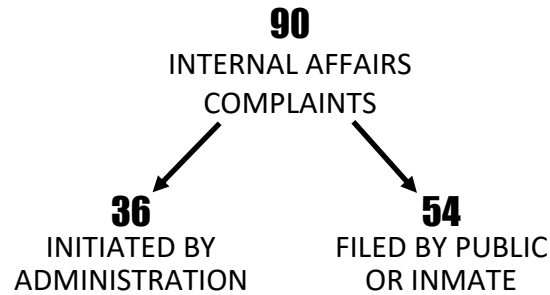

Additionally, the Department has detectives assigned to the DEA, FBI, and HSI. These detectives are deputized as Federal Task Force Officers and assist federal agencies with their investigations in Pima County. Detectives serve as a direct link to resources available through the Department.

# 2024 ADMINISTRATION

## BUREAU

The Administration Bureau is comprised of two divisions, the Community Services Division which includes an educational and engagement component with the community. Engagement encompasses a myriad of resources, including interaction with the media through public information officers, the neighborhood watch program, the Sheriff's Auxiliary Volunteers (SAV) program, social media platforms, recruitment fairs, and attendance at various community events and meetings. The School Resource Officers (SRO) Unit provides a secure environment in schools and assist in the mentorship with youth. The Wellness Program ensures employees maintain good mental, psychological, and physical health essentials for law enforcement to be effective in keeping themselves and our community safe.

The Human Resources Division (HRD) is responsible for all human resource processes to expand the Department with skilled deputies, corrections, and civilian staff. This division oversees the Training Section for corrections officers and ensures training is compliant with state mandated certification for commissioned personnel. The HRD assures the Department makes ethical, lawful, and policy driven decisions related to the hiring, management, retention, discipline, and termination of personnel.

# 2024 SUPPORT

## BUREAU

The Support Bureau consists of two divisions, Support Services and Tactical Support Divisions. The Support Services Division includes three essential components to the Department, the Communications Section answers all 911 calls and dispatches deputies. The Material Management Section is tasked with the inventory and upkeep of fleet, equipment, supplies, and facilities. The Records Management Section is the custodian of all records for the Department and manages the state and county retention schedules for all records.

The Tactical Support Division consists of two sections, the Tactical Response Section (TRS) and the Traffic Safety Section (TSS). The TSS is comprised of several units: Motors, DUI, Traffic, and Criminal Interdiction Units (CIU). This section is responsible for advanced collision and DUI investigations, providing training, coordinating the Department's unmanned aircraft systems (UAS), and providing enforcement resources to address community traffic safety concerns. The CIU Unit provides enforcement and intelligence support to internal and external law enforcement partners with special emphasis on disrupting illicit smuggling operations.

# Department Accomplishments

## PIMA COUNTY SHERIFF'S DEPARTMENT

### ★ Innovation & Technology

#### **Technology & Innovation Steering Committee:**

The last four years, we have raised staffing levels, increased deputy and corrections salaries, and reduced crime rates; and in January of 2024, the first meeting ensued taking the PCSD another leap forward by ensuring our department remains at the forefront of technological innovation with the formation of the Technology & Innovation Steering Committee. This step forward has modernized our operations and enhancing public safety through strategic technological advancements. This committee has streamline processes, enhanced efficiency, and continued strengthening the safety of Pima County residents.

This initiative reflects our commitment to progress, efficiency, and transparency by leveraging cutting-edge solutions to improve law enforcement practices. The committee, composed of subject-matter experts, deputies, corrections staff, and civilian staff, has focused on:

- Identifying innovative tools to enhance officer safety, crime prevention, and investigative capabilities.
- Strengthening our approach to crime reduction through advanced analytics and smart resource allocation.
- Improving department-wide connectivity, emergency response efficiency, and digital security measures.
- Exploring new methods to share information with our community while ensuring accountability in policing.

**TraCS Technology:** In partnership with the Arizona Department of Public Safety and Arizona Department of Transportation the PCSD implemented an electronic citation and crash reporting system. The Traffic Safety Section facilitated the acquisition of hardware to further the implementation of an electronic traffic citation and crash reporting system (TraCS). 98 mobile printers, barcode scanners, and associated peripherals were purchased utilizing grant funds awarded by the Governor's Office of Highway Safety. TraCS implementation continues to advance in coordination with the Pima County Information and Technology Department.

**SPIDR (Versaterm) Community Connect Technology:** SPIDR is a system that enables the PCSD to automatically send text or email updates to community members regarding their 911 calls for service, as well as provide investigative updates throughout the case, essentially improving communication and fostering greater community engagement by keeping people informed about the status of their reports and investigations.

**Winscribe:** Is a dictation application the PCSD implemented for deputies to streamline and automate deputy reporting to improve responsiveness and deputy productivity in the field. Winscribe is a faster and more accurate tool to efficiently create incident reports and deliver mission-critical information.

### *Innovation & Technology continued...*

#### **LexisNexis® Desk Officers Reporting System (DORS):**

In 2024 the PCSD launched the LexisNexis® DORS , a new reporting tool designed for the community to report non-emergency incidents online ranging from animal problems, crime tips, custody order violations, fraudulent use of a credit card, harassing phone calls, hit and run, identity theft, lost property, private property accidents, supplement property lists, theft, suspicious activity, traffic complaints, and vandalism. DORS is accessible through computers, smartphones, and tablets, offering a fast and efficient way to report minor problems. This system will expedite the reporting process and provide users with essential documentation for their records, while freeing up deputies in the field to respond to emergency calls that require immediate attention. This system allows the reallocation of valuable officer resources that can take anywhere from 10-30% of your overall reports online. It also proactively focuses on crime trends and aides in the decrease in response time to priority calls.

**Drone Technology:** The PCSD has invested and implemented new drone technology to leverage investigative and patrol law enforcement efforts. Drones are one of many technologies law enforcement agencies are increasingly employing because of the many benefits, such as the rapid deployment, its cost-effective in usage of personnel and the reduction and risk of dangerous environments. Drones can also cover large areas and provide real-time valuable intelligence/information to deputies and commanders during critical situations.

**Body-worn Cameras Upgrade:** The PCSD upgraded our existing body-worn cameras to the latest and most technologically advanced version available. Our cameras are now equipped with an enhanced sensor for clearer, and more detailed pictures, a wider field of view for increased visibility, and longer battery life, reinforcing our commitment to public safety and transparency.

**LexisNexis® Virtual Crime Center Technology:** Currently the PCSD is in process of procuring LexisNexis® Virtual Crime Center. This tool will enhance investigative resources, share community crime mapping information with our public constituency, and patrol division crime statistics.

**Radio Upgrades (Corrections):** The PCSD secured 3.5M grant and purchased upgraded handheld radios for Corrections Bureau to improve communications and safety. Moving in to 2025, our plans are to pursue additional radios for Commissioned deputies.

**Optisigns:** The PCSD expanded the department video and digital signage for its lobbies with informative announcements as part of employee outreach and a communication haven for employee to be engaged.

### ★ Community Policing

**Special Enforcement Team (SET):** The Special Enforcement Team (SET) began operations in January 2024. The unit enhances safety on Pima County roadways via multifaceted strategy including timely response to community reports of unsafe traffic conditions, high-visibility presence at intersections prone to collisions, proactive enforcement of hazardous driving violations, and community education to achieve compliance with traffic laws. SET unit was created to address quality of life and community concerns, respond to constituent complaints, and tips. Deputies are now visible and proactively reducing crime in places of elevated risk. Presence of law enforcement deters crime in these elevated risk areas.

SET coordinated with Community Resources to develop and distribute educational pamphlets and videos to educate the public on topics such as off highway vehicle operation, reacting to aggressive drivers, and obeying speed limits.

### ★ Infrastructure

**San Xavier District Office update: (SXDO):** Following a 2021 evaluation of district boundaries and deputy response times, it was determined that a relocation of the SXDO was necessary to better serve the Southwest region of Pima County. As a result, we moved forward with this critical project, ensuring our deputies can respond more swiftly and efficiently to calls for service in this area.

In collaboration with Pima County's Project Design and Construction Department, groundbreaking on the new facility strategically located at 4774 W. Valencia Road, Tucson, Arizona, took place, marking a key milestone in our commitment to community safety and accessibility. With significant construction. . .

progress in 2024, we are now anticipating a tentative grand opening in April 2025.

The relocation of the SXDO is more than just a new building it represents a strategic investment in faster response times and improved service delivery. Public safety remains our top priority, and this project is a testament to our dedication to the residents of Pima County.

**Pima Regional Training Center (PRTC) – Shooting Range update:** In 2024, the PCSD began the arduous procurement process of obtaining a single source vendor to replace the target systems with a newer technology system. The high volume of regional usage of the two turning target systems at the Regional Shooting Range, the systems have exhausted their expected service life and the vendor was no longer able to service. A vendor was chosen and we have moved forward and expect to have them replaced the early part of 2025.

**PRTC Facility Security enhancements:** The PCSD received some special Grant Funded HIDTA money to apply towards some Pima Regional Training Center improvements for security purposes. These improvements included a 4,214' linear foot of 18" Concertina wire around the entire perimeter fencing. We also added a galvanized 1" security cable wrapped through the entire west end of the fencing for reinforcement purposes. A new rolling gate system which is electronically operated and access will be controlled by a mag card system. The magazine locker has a new security rolling gate shutter along with expanded concrete slab for easier access into the magazine with reinforced metal bollards surrounding the entrance to prevent vehicle access.

**PRTC Classroom enhancements:** Training classrooms 3 and 4 recently had all audio-visual equipment upgraded replacing the outdated equipment. Both classrooms now have two 75" monitors that are controlled by Multi Touch wall plate and room controllers along with cameras and microphones to better assist in lectures during various training.
